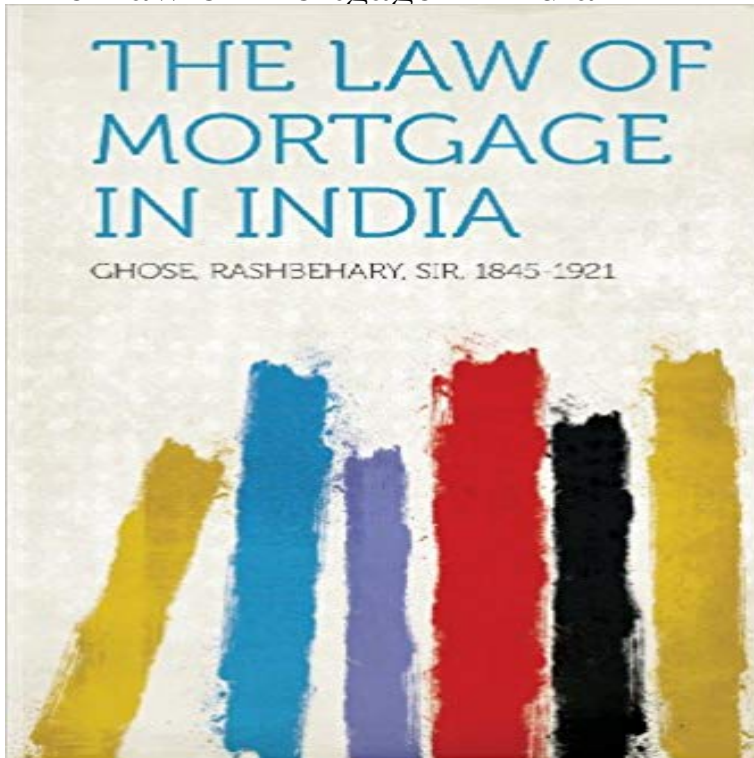


The Law of Mortgage in India
