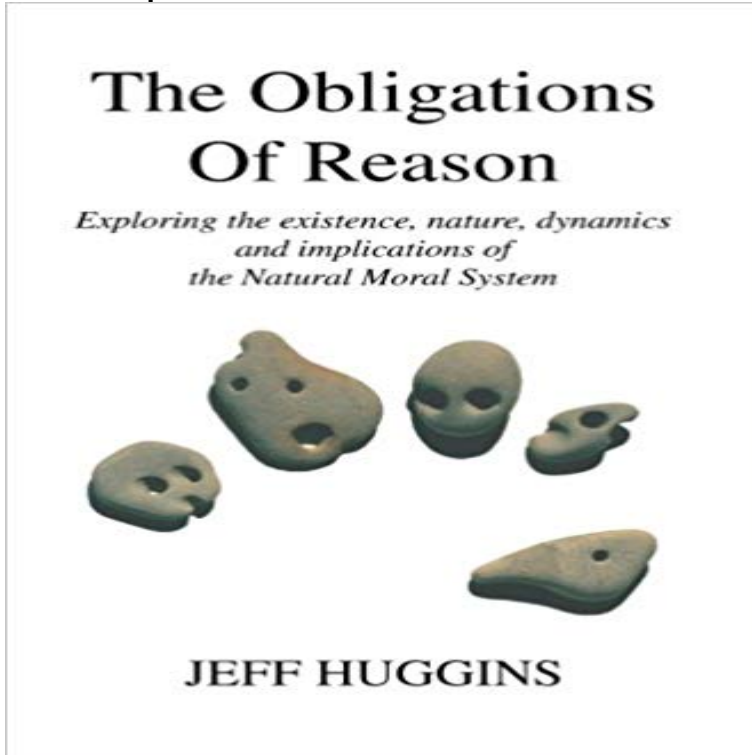


# The Obligations Of Reason: Exploring the existence, nature, dynamics and implications of the Natural Moral System

What are the obligations of political and corporate leaders, scientists, educators, and others to use the human gift of reason to help improve the human condition? Integrating recent advances in scientific understanding, and viewing them from the standpoint of questions traditionally asked by philosophers, Jeff Huggins addresses these questions of immense relevance to the sustainability and quality of human life, biodiversity, and the environment as well as to our everyday lives as modern humans.
