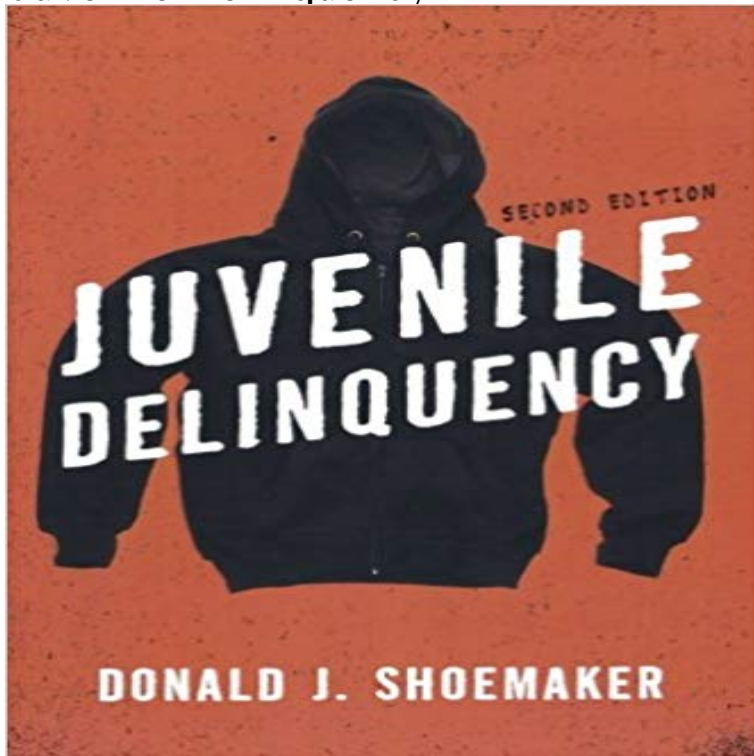


Juvenile Delinquency
