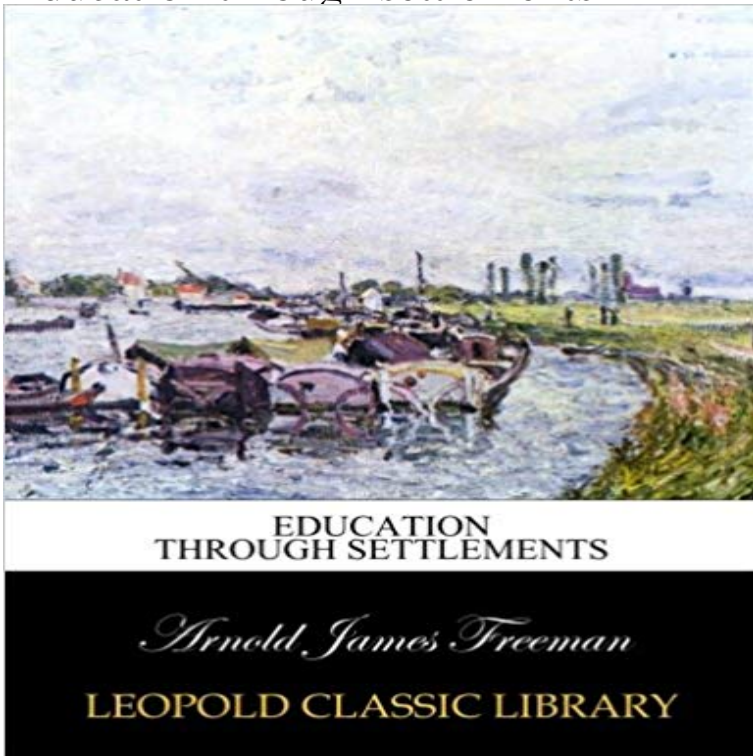


Education through settlements
